Membership Protocols and Responsibilities:

1. Membership meetings are on the 3rd Tuesday of the month. Location of meeting will be announced at the prior months meeting.
2. All members **must be present** to vote on any 'member at large' issues
3. Only one individual can vote per meeting. If you are a business, that business can designate an individual to represent that business at any OED meeting and can also vote on behalf of that business. If that designated business representative happens to also have an individual based membership they can only vote once, either as an individual or as a business representative but not both. Therefore please be careful to designate you alternative business representative(s).
4. Only those who raise their hand to be heard in a meeting will be acknowledged and allowed to speak. Roberts Rules of Order are in place at all times
5. We try to limit all meeting to one hour +/-
6. Payment needs to accompany all applications.
All applications need to be complete, if any information does not apply please designate 'N/A'
As necessary
7. All membership applications received on or after 10/31/2018 will be active and in good standing members up to and through the next calendar, 12/31/2019, with all voting rights commencing upon receipt of paid membership applications.
8. Any voting member who wishes to bring up an issue or concern for the next upcoming meeting needs to contact our President to make a request of their concern to be placed on the next agenda.
9. Only current qualified members in good membership standing can vote on member at large issues as required by Oakland Economic Development (OED) bylaws and Oregon DOJ oversight. A members in good standing is a person who has completed an OED application along with the current year's membership payment.
